Dear Representative,

As you are probably aware, July 30 is the 45th anniversary of the enactment of Medicare.

On this historic occasion, the Leadership Conference for Guaranteed Health Care reaffirms its support for the Medicare program and calls for its improvement and expansion to cover all residents of the United States.

Representing a membership base of about 20 million people, the LCGHC is a national coalition of labor, faith, civic, physician and nurse organizations who support single-payer national health insurance, i.e. an improved Medicare for all. Polls show this solution has the backing of about two-thirds of the U.S. public.

By expanding Medicare to everyone, and by replacing the crazy-quilt, inefficient, profit-driven system of multi-payers that our system presently has with a streamlined single-payer system, our nation would save about \$400 billion annually in unnecessary, wasteful administrative costs.

An improved Medicare for all would also possess powerful cost-control tools, such as the ability to negotiate fees, purchase medications in bulk, develop global budgets for hospitals and coordinate capital investments.

Such economies would allow us to provide health coverage to everyone, with no co-pays or deductibles, and yet require no net increase in overall U.S. health care spending.

Regrettably, the new health law falls far short of this standard. Moreover, recent hints of cuts to the Medicare, Medicaid and Social Security programs, emanating from members of the National Commission on Fiscal Reform and Responsibility, suggest new threats to our nation's safety nets. We categorically reject such a course of action.

The organizations listed support the U.S. National Health Care Act, also known as Expanded and Improved Medicare for All

We therefore respectfully urge you to:

- * Speak out strongly in opposition to any cuts in existing Medicare benefits (or to increased premiums and co-pays, or postponing the age of eligibility).
- * Speak out strongly in opposition to any cuts in Social Security, another pillar of our nation's health and economic security, or to the postponement of the eligibility age, its privatization, or the investment of the trust fund's money in the stock market.
- * Support legislation that would bring about an improved Medicare for all, i.e. single-payer national health insurance, like S. 703 and H.R. 676.
